



North Little Rock APPE Opportunities

Pharmacists at Baptist Health Medical Center - North Little Rock work with the healthcare team to ensure positive patient outcomes. Services provided by pharmacists span beyond decentralized clinical consultation (dosing - pharmacokinetic, antimicrobials, anticoagulation; antimicrobial stewardship - culture review, de-escalation; IV to PO; nutrition support; electrolyte replacement; etc.) to include Graduate Medical Education integration, multidisciplinary rounds, and transitions of care.

Why Choose BHMCLNR?

Collectively, as a department, we feel there is great value in the experience that students gain at our facility. Our institution serves a wide variety of patient populations and numerous medical specialties that allow for a well-rounded adult medicine experience. Students will work closely with their preceptor and other pharmacists, pharmacy residents, medical residents, and physicians to appropriately design, implement, monitor, evaluate, and adjust patient specific pharmacotherapy care plans.

BHMCLNR Overview

- 225 licensed beds
- 6 clinical pharmacists, 1 emergency department pharmacist, 1 psychiatry pharmacist, 1 pharmacy resident on staff each day
- Antimicrobial stewardship pharmacist, and 1 pharmacy resident on staff each day
- Majority of preceptors are BPS board certified pharmacists

Learning Opportunities

- Engage with other healthcare professionals on multidisciplinary rounds – intensive care unit, rehab, and family medicine teams
- Provide continuing education for pharmacists and other healthcare professionals
- Participate in P&T Committee meetings
- Complete an MUE or drug monograph
- Participate in at least one journal club and provide at least two patient case presentations

- Opportunity to complete a 3-5 month APPE at one facility (longitudinal experience may be in the spring or fall depending on your specific college of pharmacy)
- Build rapport with physicians and other healthcare professionals

- No need to learn a new EHR each month
